We are excited you are interested in joining the 2026 **Dudley Farm Farmers Market *and More!***

We have added "*More!*" to our name and advertising this year to highlight both the fantastic variety of products on offer at our Market as well as the museums, historic demonstrations, animals, and events available for visitors each week. All of this is what makes Dudley Farm such a one-of-a-kind CT treasure!

The **Farmers Market will continue to be held** at 2351 Durham Road, Guilford CT (corner of routes 77 & 80), beginning May 9 until October 31, between 9:30am-12:30pm.

**Please review the following Vendor Application Form and additional 2026 Vendor Guidelines:**

1. **Please read carefully and agree to all of the 2026 Dudley Farm Vendor Guidelines before completing the 2026 Vendor Application Form.** Any questions should be directed to Sean, Market Manager, at [marketmanager@dudleyfarmfoundation.com](mailto:marketmanager@dudleyfarmfoundation.com)  
The Market Manager will respond to all applications, questions, and inquiries within a timely manner.
2. **Complete the following 2026 Vendor Application Form below or [by following this link.](#)** Any application forms received after April 15, 2026 may not guarantee placement in the current season's market. All market vendor fees must be paid on time by Venmo, PayPal, Cash, or Check (made payable to The Dudley Foundation).
3. **Dates and Times of the 2026 Dudley Farm Farmers Market *and More!***
  - a. The Market will be held every Saturday,
  - b. 9:30am - 12:30pm,
  - c. May 9 - October 31 (26 weeks)
  - d. Vendors should plan to arrive 30 mins before the market opens to setup their stand and plan to remain 30 mins after closing for take down and cleanup
4. **Market Vendor Fee Options**
  - a. **Visiting Vendor:** \$25 week-to-week fee paid before the start of each market
  - b. **Member Vendor:** \$25 annual fee + \$10 week-to-week fee, minimum 2x month
  - c. **Season Vendor:** \$200 upfront once-a-season 30% discounted fee, up to 26 weeks
  - d. **Holiday Market:** Season and Member Vendors will also receive a discount and priority to attend December Holiday Market Dates

5. **Items for Sale:** All products for sale at Dudley Farm Farmers Market *and More!* must be homegrown or handmade. All produce, meat, eggs, prepared foods, and body products at the Market must be grown, raised and/or prepared in the State of Connecticut by the vendor themself.
6. **Vendor Insurance:** All Vendors must provide current Proof of Insurance/Certificate of Liability to the Market Manager before attending any Market function as a vendor. Vendor specific insurance policies can be secured for approximately \$25/month through sites such as, Fliprogram.com and ACTinsurance.com. The Dudley Foundation should be named as “additional insured.” In addition, the Dudley Foundation and its volunteers will not be held liable for any damage caused to products as a result of assisting with set-up or breakdown of market space.
7. **Equipment:** Vendors must supply their own tables, chairs, pop-up tents, etc. Outdoor spaces, approx. 10’x10’, will be provided to all Vendors. Size accommodations and location requests will be decided at the discretion of the Market Manager. Vendors may determine the methods of payment they will accept, but stable wifi internet access cannot be guaranteed.
8. **Facility:** Restrooms are available on-site.
9. **Publicity:** The Market will be publicized via our mailing list, in local newspapers and event websites, on social media, on sandwich boards outside the Farm and (when possible) on the Guilford Green, in mailers, and on posted flyers in local Guilford, Madison, Branford, North Branford, and North Madison businesses. Digital copies of flyers and advertisements can be shared with Vendors, and we encourage you to highlight your products and market events with your followers, as well! The Dudley Foundation does not guarantee the volume of customers or vendor sales.
